





FOREWORD

The ever-increasing level of skills essential nowadays to the individual's social, cultural and occupational integration into a constantly changing society has led the Member States of the European Community to promote entry to higher education for an increasing number of young people.

At the same time, the desire to combine this democratisation of education with a high quality training, the economic problems encountered in most Member States and a contraction of the supply side of the labour market have forced them to define, to a greater or lesser degree, entry conditions and requirements restricting admission to higher education.

Student mobility within the European Community is inseparably linked to the requirements for entry to higher education in the various Member States. **What qualifications are required? Are there entrance examinations or competitions? Are there restrictions on numbers admitted, generally or partially (*numerus clausus*)? Are the qualifications obtained, or periods of study undertaken, in another country recognised? What language requirements are there? What enrolment, immigration and residence formalities must be met by European students wishing to study in another Member State?**

The promotion of an open European space for cooperation in higher education has already been discussed at Community level on numerous occasions. This topic, and more especially student mobility, is once more high on the agenda both under the Belgian Presidency and for the work of the Education Committee.

Recognising the need for information on these questions, and more particularly in the context of the Education Committee's work at Community level, the Task Force Human Resources, Education, Training and Youth of the EC Commission has asked EURYDICE to prepare a summary report on the main requirements for admission to higher education in the European Community.

In producing this document, the EURYDICE network hopes to continue to contribute to greater mutual understanding within the European Community in the field of education. The European Unit would like to thank A. and D. Lafontaine and S. Terwagne for their help in coordinating the work on this document and in particular for preparing the résumé.

**ENTRY TO HIGHER EDUCATION:
SYNOPSIS**

1 - ENTRY REQUIREMENTS: QUALIFICATIONS AND EXAMINATIONS

For admission to higher education, students must normally fulfil one or more conditions. They must hold an upper secondary school-leaving certificate or equivalent and/or enter an entrance examination or competition.

The school-leaving qualification is generally the minimum requirement in all Member States, but this is increasingly insufficient to guarantee a candidate freedom of choice of institution and/or course. In addition, some countries require entrance examinations for some or all areas of study, and in some cases personal interviews. For courses in art and sports, candidates generally have to take an aptitude test.

Entry requirements may vary depending on which of the following four categories the student falls into:

- nationals of the Member State;
- EC nationals holding a qualification from the Member State in which they wish to study;
- EC "transfer students" not holding a qualification from the Member State in which they wish to study;
- participants in the exchange programmes (LINGUA, COMETT and ERASMUS in the main), who are subject to the rules of the relevant programme.

In most cases, entry requirements vary only slightly for the different categories of students within any given country. However, for a student who wishes to study in another Member State of the EC, they may vary considerably depending on the country chosen. Thus, to mention only a few examples, a Belgian student wishing to study in Greece or Portugal would not be required to take the entrance examinations demanded of Greek or Portuguese students; however, the same student going to Spain would have to take the general entrance examination. A Spanish student wishing to study in Denmark would have to provide evidence of having passed the entrance examination in Spain, although Danish students do not have to take an entrance examination in their own country.

2 - ENTRY REQUIREMENTS: RESTRICTIONS ON ADMISSIONS

A large majority of Member States have systems for restricting the numbers of students admitted (*numerus clausus*), either partially (6 countries) or generally (4 countries). Luxembourg not having a full university, the only real exception is Belgium which places no limits on student admissions.

- 1 - Some systems of higher education, notably those of Ireland and the United Kingdom, do not impose a quota system in the strictest sense of the term, but nonetheless apply very selective procedures for admission to some or all types of studies.
- 2 - Foreign students from within the EC holding the national qualification or qualifications required for entrance to higher education in the Member State where they wish to study are treated in the same way as students of that country.
- 3 - Foreign students from within the EC, referred to as "**transfer students**", must have "equivalent" qualifications to be admitted to a foreign system of higher education. In general, qualifications are considered equivalent when they are similar to those required for admission to higher education in the student's **host Member State**, although in some Member States (Belgium, for example), equivalence is accorded to those qualifications which grant entry to higher education in the **student's own Member State**.
- 4 - The wide diversity of national regulations imposing quota restrictions (*numerus clausus*) and other forms of selection have led students in the Community to demand to be treated in the same way as "national" students in other Member States where admission requirements are less strict than in their own State. This applies in particular to courses such as medicine, veterinary medicine and dentistry, entry to which is sometimes severely restricted, the number of places falling short of demand (for instance, in Greece and Ireland).
 - I. No restrictions on numbers or selection (for students with the required qualifications).
 - II. Partially restricted or selective entry.
 - III. Restricted or selective entry (*numerus clausus*) throughout the entire higher education system.

3 - RECOGNITION OF QUALIFICATIONS AND PERIODS OF STUDY

Improvement of student mobility within the EC is dependent upon the following conditions:

1. "Transfer" students should have their qualifications recognised on entry to a higher education institution. It should be possible for this to be done at different stages in the course:
 - For entry at the beginning of a course, the situation is fairly clear.
 - For entry during a course, there are only a few bilateral or multilateral agreements on intermediate qualifications.
 - For entry at the PhD stage, this depends largely on the institution concerned and is decided on an individual basis or on the basis of bilateral agreements, as the case may be.

2. Students on exchange programmes should have their periods of study abroad recognised so that they count officially as part of their course in their own Member State.

Recognition of qualifications is provided for under the multilateral conventions of the Council of Europe and Unesco, in bilateral agreements between Member States or on a unilateral basis by individual Member States. The NARIC¹ network (part of the ERASMUS programme) centralises information regarding recognition and equivalence.

These Conventions encourage the recognition of qualifications both on initial entry to higher education and at the intermediate and final levels.

C. Bilateral agreements and unilateral recognition

There are relatively few agreements of this type between Member States. Even where there are none, it does not mean that diplomas, degrees and other qualifications are not recognised by other Member States. There may be multilateral agreements in force, or the qualifications awarded in other Member States may be recognised generally. Qualifications may also be recognised on an individual case basis.

2. RECOGNITION OF QUALIFICATIONS IN PRACTICE

As has been demonstrated, there are only a few bilateral agreements between Member States or instances of unilateral recognition. This means that in practice problems of recognition are often dealt with on an individual case basis. The institutions responsible for these decisions differ greatly from one Member State to another. Where certain problems of equivalence do arise, they can be solved either by taking tests or by entering the course at a lower level.

This table gives only a brief résumé of the situation in practice. It is impossible to summarise the situation as regards the recognition of university qualifications.

4 - LANGUAGE REQUIREMENTS

One of the main obstacles to the mobility of students is still their inadequate command of the languages in which courses are given in the host countries. Most Member States demand a certain level of proficiency in their language and require foreign students to take a language test on entry, unless they either have documentary evidence of such proficiency or have taken an entrance examination in the language of the country. In some Member States, these requirements are national while in others they are set by the institutions concerned.

Courses given in a foreign language

Courses with an international orientation are given in English in Belgium, in Denmark, in Germany (at post-graduate level) and in the Netherlands, while in Flanders (Belgium) and in the Saarland (FRG), some courses are given in French.

Language training

Language courses for foreign applicants are also available in all Member States during the academic year. Many Member States also provide intensive summer courses.

For those who wish to study in their home country, some Member States have organisations for the dissemination of their culture in the other Member States - France (Alliance française), Germany (Goethe-Institut), the UK (British Council), Italy (Dante Alighieri) and Spain (Instituto Cervantes).

Language requirements for exchange programmes

- In selecting students, the home institutions are expected to take account of their language skills. Only a few Irish institutions require students to sit a standardised test or have an interview.

- Within the framework of the ERASMUS Programme, many Member States offer special language courses to students involved in exchanges. These courses are free of charge if within the budget of the Inter-University Cooperation Programme (ICP).

- I Registration directly with the institution.
- II Application through a central organisation.

6 - IMMIGRATION AND RESIDENCE FORMALITIES

Students wishing to pursue higher education courses in another EC Member State must comply with a number of formalities which can vary depending on the length of their stay.

In most countries, a student planning to stay in another Member State for more than 3 months (6 months in the UK) must produce one or more of the following documents in order to obtain a residence permit in the host country:

- I Passport or national identity card.
- II Proof of enrolment in an institution of higher education.
- III Proof of medical insurance.
- IV Proof of sufficient funds to cover living costs.
- V Proof of accommodation.



The ratio of the first-entrants to the number in the population at the theoretical entry age.







The term "foreign students" is applied to students enrolled in higher education institutions in a country of which they are not nationals, except in Ireland and the United Kingdom, where the term applies to students not permanently resident in the host country.



NATIONAL SUMMARIES

BELGIUM - FRENCH COMMUNITY

1 - ENTRY REQUIREMENTS: QUALIFICATIONS AND EXAMINATIONS

a. National students and EC students holding the qualification of this Member State.

For short-type higher education: an upper secondary school leaving certificate.

For long-type higher education and university education: an upper secondary school leaving certificate and a certificate of aptitude for higher education.

Entrance examinations are required in some cases (for civil engineering studies, military schools and some specialised schools).

b. EC "Transfer" Students

A secondary school leaving certificate recognised as equivalent to the certificate of upper secondary studies (short-type) and certificate of aptitude for higher education (long-type and university education).

Entrance examinations are required in the same subjects as for national students (there is no specific entrance examination for non-Belgian students).

2 - ENTRY REQUIREMENTS: RESTRICTIONS ON ADMISSIONS

Belgium does not apply a system of *numerus clausus*. All students who hold the standard qualifications required for entry to higher education may be admitted. For this reason many students from other Member States which do apply *numerus clausus* come to Belgium to study, particularly those who wish to pursue courses for which demand is high and for which a very strict *numerus clausus* is applied in their home country.

3 - RECOGNITION OF QUALIFICATIONS AND PERIODS OF STUDY

During the 1960s, Belgium signed bilateral agreements on automatic recognition with the following countries: the Federal Republic of Germany, France, Luxembourg, Italy and the Netherlands. These agreements must be updated to reflect developments in the education systems of the countries involved; they are no longer systematically applied and students from these countries must request recognition of their qualifications. In practice, recognition is generally granted.

Recognition of Qualifications in Practice

Institution responsible: Ministry of Education, Research and Training.

Few problems arise concerning entry into higher education. For entry at an intermediate level, students are required to complete additional work if the content of the part of the cycle which they completed in their home country does not correspond to that of the same part of the cycle in the Belgian French-speaking Community.

Recognition of Periods of Study and Credits in Exchange Programmes

Conditions: No equivalence required.

Recognition of Periods of Study:

Certificate of attendance (after three months).

Certificate of completion of examinations (after one year).

Credits: As provided for in the exchange programme.

4 - LANGUAGE REQUIREMENTS

National requirements:

None.

Requirements of institutions of higher education:

None. However, since education is given in French, students must have sufficient mastery of the language (including Belgian students whose first language is not French, but Dutch or German).

Courses in a foreign language:

The universities of the French-speaking Community provide education in specialised third-cycle courses in foreign languages (English, French/English, French/German).

Exchange Programmes (ERASMUS)

After completing formalities, the student receives an *attestation d'immatriculation au registre des étrangers* (foreigner's registration card) which is valid for one year and has to be renewed on a regular basis throughout the period of study.

BELGIUM - FLEMISH COMMUNITY

1 - ENTRY REQUIREMENTS: QUALIFICATIONS AND EXAMINATIONS

a. National students and EC students holding the qualification of this Member State.

For all higher education (university or non-university): an upper secondary school leaving certificate.

Entrance examinations are required in some cases (for studies in civil engineering and architectural civil engineering, military schools and some specialised schools providing artistic or maritime education).

Conditions of entry to long-type university and non-university education are set out in the 1953 Convention of the Council of Europe.

Belgium does not apply a system of *numerus clausus*. All students who hold the standard qualification required for entry to higher education may be admitted. For this reason many students from other Member States which do apply *numerus clausus* come to Belgium to study, particularly those who wish to pursue courses for which demand is high and for which a very strict *numerus clausus* is applied in their home country.

FEDERAL REPUBLIC OF GERMANY

1 - ENTRY REQUIREMENTS: QUALIFICATIONS AND EXAMINATIONS

Students must possess a qualification allowing entry to:

- either higher education (*Hochschulreife*)
- or studies at a *Fachhochschule* (institute of technical higher education).

Three types of qualifications provide entry to higher education:

- the general secondary school leaving certificate (the *allgemeine Hochschulreife*) which gives entry to all higher education without exception;
- the technical secondary school leaving certificate (the *fachgebundene Hochschulreife*) which gives entry to certain university studies, to establishments at university level and to *Fachhochschulen*;
- the *Fachhochschulreife*, which allows entry to the *Fachhochschule* and to integrated courses at universities (*Gesamthochschule*).

- b. *EC "Transfer" Students*

These students must have a secondary school leaving certificate which gives entry to higher education in their home country, or have been granted a university place in their home country.

2 - ENTRY REQUIREMENTS: RESTRICTIONS ON ADMISSIONS

- a. In a large number of fields of study, no *numerus clausus* is applied.
- b. Given the large number of applicants and the shortage of university places, there are restrictions on the admission of German and foreign students throughout the country in some disciplines (such as medicine, architecture, law, economics, biology, pharmacy and psychology, for example). In these subjects, places are allocated to German and EC students on the basis of the results of two centralised competitive examinations. Criteria for selection of applicants include the average mark received in the qualification giving entry to higher education and the number of semesters since obtaining this qualification ("waiting time"). In medicine, interviews at the establishment and the results of a test are also taken into account.
- c. In addition to these restrictions, which are in force throughout Germany, local restrictions on admission are also applied in some disciplines (particularly for courses in the higher technical institutions in North Rhine-Westphalia and Hesse) and in some establishments. Each establishment defines its own specific criteria for admission; these are determined in accordance with the law of the *Land* concerned.

Depends on area of study; possible mainly for courses in French and English in the third cycle (*Aufbaustudium, Zusatzstudium*).

Applications and information about admissions may be obtained from the *Akademische Auslandsämter*, from the secretariats of institutions, from German diplomatic missions or Consulates abroad or from the offices of the DAAD (*Deutscher Akademischer Austauschdienst*).

6 - IMMIGRATION AND RESIDENCE FORMALITIES

The student must obtain a residence permit from the local registration office for foreigners in Germany.

Documents required:

- * a passport;
- * a certificate of admission from an institution of higher education;
- * proof of sufficient funds to cover study costs.

On arriving in Germany, students must register with the registration office for foreigners which is responsible for the area where they will reside during their period of study.

The residence permit is renewable; requests for an extension must be made prior to the expiry date.

GREECE

FRANCE

National students, EC students holding the qualification of this Member State and EC "Transfer" Students

Conditions for entry to higher education depend on the type of studies (university or non-university) which the student wishes to pursue.

- **Universities:**

The student must hold a *baccalauréat* (general, technological or vocational) or a qualification considered equivalent, or have passed a special examination for university entrance (ESEU), either the literary (ESEU A) or scientific (ESEU B) section, depending on the studies the student wishes to undertake.

- ***Instituts universitaires de technologie (IUT) or sections de techniciens supérieurs (STS):***

The *baccalauréat* or a qualification considered equivalent is required; students are selected on the basis of their school record.

- **Public or private non-university higher education (engineering schools, business and management schools, national veterinary schools, architecture schools, etc.):**

Students admitted to this type of education are chosen from among *baccalauréat* holders.

The most prestigious schools (the *grandes écoles*) require the *baccalauréat* as well as two years of special preparation in *classes préparatoires aux grandes écoles* (CPGE) and an extremely selective competitive entrance examination.

The other schools have varying requirements for admission. All require the *baccalauréat* plus a competitive examination or assessment of the student's school record.

Entry to various levels of post-*baccalauréat* education offered by establishments under the jurisdiction of the Ministry responsible for higher education, including universities and public institutes or other establishments of higher education, may also be authorised on the basis of recognition of studies, work experience or personal achievement, as provided for in Decree No. 85-906 of 23 August 1985. This recognition either gives the student direct entry to education offered by the establishment leading to a national qualification or other degree regulated by the State or allows the student to participate in an establishment's competitive entrance

examination. Holders of foreign qualifications or degrees may request recognition. A decision will be taken by the President of the university or the director of the establishment based on a proposal put forward by its education committee.

2 - ENTRY REQUIREMENTS: RESTRICTIONS ON ADMISSIONS

Regulations are identical for nationals and foreign students.

- a. French universities do not apply a system of *numerus clausus* for registration in the first year of the first cycle. However, admission is contingent upon the number of places which each establishment has available in the area of study requested. Public or private institutes or schools under the authority of various Ministries, short university-level courses (such as university institutes of technology and upper technical sections) are selective.
- b. Selection takes place at the start of the second year of medical studies in the form of an *examen classant* or "ranking examination".

Recognition of Qualifications in Practice

Institution responsible: the establishment of higher education concerned.

There are no standard equivalences between French and foreign qualifications.

Heads of establishments are responsible for decisions regarding the academic recognition of qualifications.

Foreign students wishing to pursue university-level studies in France contact the establishment of their choice. The President of the university or the director of the establishment in question determines the admission level based on a proposal put forward by the education committee, which examines the applicant's record of previous studies together with professional and personal experience.

A 1980 agreement with Germany defines exemptions from requirements for previous courses and qualifications in the sciences, arts and social sciences and was extended to cover economics, management, political science and law in 1986.

A 1975 protocol with Luxembourg complemented by two additional protocols (1981, 1982) gives students from Luxembourg entry without pre-registration to the Universities of Strasbourg, Nancy, Paris VI and the INP of Nancy.

A 1982 framework agreement with Italy regulates inter-university agreements leading to the award of a combined *maîtrise* and *laurea*.

Recognition of Periods of Study and Credits in Exchange Programmes

Conditions: Determined by the teaching staff organising the exchange programme.

Recognition of Periods of Study:

Usually provided for and described specifically in the inter-university agreement upon which the Cooperation Programme concerned is based.

Credits: Same as above.

German students are all required to take the test, except those who have

obtained the *allgemeine Hochschulreife* with an above-average mark and those whose secondary studies were in bilingual French-German sections; Italian students from the bilingual sections of the Santissima Annunziata state high school in Florence, holders of the DALF and nationals of countries where French is the official language are also exempt.

Requirements of institutions of higher education:

Testing may be carried out by the establishment in accordance with its own regulations.

A combined system is in effect.

- a. Most students obtain application forms from the cultural service of the French Embassy in their home country. They then choose two establishments, including one outside of Paris and the Ile-de-France.
The Embassy transmits the application for enrolment to the first and then the second establishment chosen.
If the application is accepted, the student is responsible for final enrolment in the establishment.

- b. The following students may enrol directly in an institution:
- first-year students with a French, Franco-German or European *baccalauréat*,
 - German students from bilingual sections or holders of the *allgemeine Hochschulreife* with a grade equal to or above the average in French,
 - German students wishing to study arts, sciences, human sciences, law, political science or economics,
 - students coming to France within the framework of inter-university agreements,
 - stateless persons or refugees awaiting a response from the OFPRA (French Office for Refugees or Stateless Persons - *Office français pour réfugiés et apatrides*),
 - students who are candidates for a university qualification,

 - candidates for enrolment in the second or third cycle, for a preparatory class for the *grandes écoles*, for an IUT or for an establishment where entrance is determined by competitive examination.

UNITED KINGDOM

Requirements of institutions of higher education:
Highly variable. Whilst some institutions require applicants to pass the British Council IELTS test (International English Language Testing System), others have no official procedure.

Courses in foreign languages:

Language training:
Most universities offer language courses, but these are very expensive as they are not subsidised: ± £ 1,200 for 12 weeks (25 hours per week).

Based on mutual trust; home institutions are expected to take language proficiency into account when selecting students.

**5 - APPLICATION AND REGISTRATION PROCEDURES FOR EC
"TRANSFER" STUDENTS**

Application is made to individual institutions through the Universities and Colleges Admission Service (UCAS), which serves as a clearing house secretariat for full-time courses leading to first degree and Higher National Diploma. Applications for part-time courses must be made direct to individual institutions. As of 1993, UCAS brings together the former Universities Central Council for Admissions and the Polytechnics and Colleges Admission System. ADAR operates as a clearing house for studio-based art and design courses except in Scotland where the Art Colleges operate a separate system. (In Scotland applications should be directed to the College of first choice.)

Admission and registration is the responsibility of individual institutions (see 1 above).

6 - IMMIGRATION AND RESIDENCE FORMALITIES

a. For short stays (less than six months).

No particular requirements for students from the EC.

b. For long stays.

The student must apply to the Home Office for a residence permit, which may be renewed on an annual basis.

Documents required:

- * passport or identity card;
- * proof of enrolment in full-time study in an institution of higher education;
- * proof of sufficient funds to cover living expenses.

Educational cooperation in the

The education systems in the twelve EC Member States vary considerably and this variety, which is the result of historical and cultural factors, is itself a source of wealth. In order to ensure that this diversity does not become an obstacle to the free movement of people, it is essential to provide effective information on the operation and structures of the education systems.

It is also vital for each country to benefit from the experience of its Community partners and thus contribute to the development of European educational cooperation.

In February 1976, the Council of the European Communities and the Ministers of Education adopted an action programme in the field of education (1) and agreed among other things to set up an information network.

This information network, known as EURYDICE, is designed therefore to underpin educational cooperation within the European Community.

It was recognised in 1990 as the chief instrument for providing information on national and Community structures, systems and developments in the field of education (2).

Each Member State has, in accordance with its own distinctive education structures, designated at least one Unit to participate in the network and the Commission of the European Communities has set up the EURYDICE European Unit.

The functioning of EURYDICE is based on cooperation among all the Units. In addition, the European Unit coordinates and animates the network.
